<b>Cieľ predmetu:</b> The aim is to enclose of european legal thought on the basis of private law. The development of private law will be described from the times of roman law, through the thinking of glossators as their started to apply the metodical criticism. Enclosed will be the interactions between the medieval legal thinking and philosophical ideas of that eras. Medieval law schools, Enlightenment, scholasticism, classicism or Savigny and his historical school. This resulted in the codifications of civil law which deserve the name „ great “ because of their great importance and influence on later legal developmant. After this general description of private law development we will focus on the development of some institutes of private law as legal acts or contracts.
